Personal Accident policy by New India Assurance

Table A

1. Death only 100%
2. Loss of 2 limbs/2 eyes or 1 limb &; 1 eye - 100%
3. Loss of 1 limb or 1 eye - 50%
4. Permanent Total Disablement (PTD) from injuries other than those named above -100%
5. Permanent Partial Disablement (PPD), % of Capital sum insured (CSI) (it varies from 1% to 75% as stated in chart in manual)
6. Temporary Total Disablement (TTD) at 1% of CSI upto 100 weeks (However limited to CSI)

Table B

1. Death only - 100%
2. Loss of 2 limbs/2 eyes or 1 limb &; 1 eye - 100%
3. Loss of 1 limb or 1 eye - 50%
4. Permanent Total Disablement (PTD) from injuries other than those named above -100%
5. Permanent Partial Disablement (PPD), % of Capital sum insured (CSI) (it varies from 1% to 75% as stated in chart in manual)
